The Character Group plc (AIM: CCT), has today received notices from Mike Hyde (a Non-Executive Director of the Company) and Mr Kiran Shah (the Joint-Managing Director and Group Finance Director of the Company) notifying the Company of share transactions effected by them respectively as follows

- Mr Hyde has disclosed that he gifted and transferred 36,528 ordinary shares of 5 pence each in the capital of the Company ("Ordinary Shares") to charity for nil consideration on 7 August 2024. Following this transaction, Mr Hyde's interest in shares in the Company is 200,000 Ordinary Shares, which represents approximately 1.07% of the Company's issued voting Ordinary Share capital.
- Mr Shah has disclosed that he has today sold 20,000 Ordinary Shares at a price of 276p per share and, through his personal pension plan, has purchased 20,000 Ordinary Shares at a price of 276.15p per share. Following these transactions, Mr Shah's interest in Ordinary Shares remains unchanged at 1,928,766 Ordinary Shares, which represents approximately 10.33% of the Company's issued voting Ordinary Share capital.
